The agenda was presented for review. Bussard moved, seconded by Johnson to approve the agenda. Roll call vote was taken with all present voting yea. Motion carried.

At 10:18 a.m., Walker moved, seconded by Hackney to return to regular session. Roll call vote was taken with all present voting yea. Motion carried.

Hackney moved, seconded by Walker to accept the resignation of Deanna Worman, ED Teacher, effective June 12, 2018. Roll call vote was taken with Johnson, Bussard, Kraemer, Quick, Long, Walker, Croy, and Hackney voting yea. Motion carried.

Johnson moved, seconded by Quick to employ Amelia McPheron, Paraprofessional, Belinda Guzman, MSI Teacher, Alexis Lockhart, ECE Teacher, Tasha Thompson, Autism Teacher, and Cary Church, ED Teacher, for the 2018-2019 school year. Roll call vote was taken with Johnson, Bussard, Kraemer, Quick, Long, Walker, Croy, and Hackney voting yea. Motion carried.

Bussard moved, seconded by Walker to accept the retirement of Yvette Baltzell, School Social Worker, effective October 3, 2022 of the 2022-2023 school year. Roll call vote was taken with Johnson, Bussard, Kraemer, Quick, Long, Walker, Croy, and Hackney voting yea. Motion carried.

Quick moved, seconded by Bussard to approve the Amended 2017-2018 Budget. Roll call was taken with all present voting yea. Motion carried.

Bussard moved, seconded by Hackney to place the 2018-2019 Tentative Budget on 30-day public review. Roll call was taken with all present voting yea. Motion carried.

The Case Study Evaluation report was presented for review. Overall the districts have requested 11 more case study evaluations during the 2017-2018 school year.

The summer in-services held on June  $4^{th}$  and June  $5^{th}$  at SESE were very successful.

Classroom locations were reviewed for 2018-2019 school year.

There was a brief discussion about an open ECE Teacher position. Director Weems expressed concerns about playbased being covered since the cooperative is short an ECE Teacher.
