The Case Study Evaluation report was reviewed.

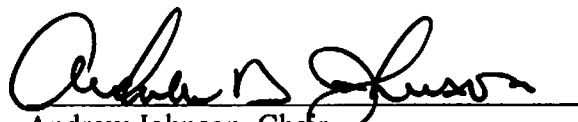
Economic Interest Statements were distributed.
