TENTATIVE MINUTES

The February meeting of the South Eastern Special Education Executive Board was held Wednesday, February 26, 2020 at 9:30 a.m., at the SESE Central Office in Ste. Marie, IL. Jakie Walker, Acting Chair for the SESE Executive Board, called the meeting to order at 9:37 a.m.

Members present: Andy Johnson, Chris Simpson, Julie Kraemer, Josh Quick, Jo Campbell, Jeff Patchett, Cathy Croy, Travis Wyatt, Joel Hackney, and Chair Walker.

Members absent: Doug Daugherty.

The agenda was presented for review. Wyatt moved, seconded by Kraemer to approve the agenda. Roll call vote was taken with all present voting yea. Motion carried.

The consent agenda was presented for review. Simpson moved, seconded by Quick to approve the consent agenda. Roll call vote was taken with all present voting yea. Motion carried.

Hackney moved, seconded by Johnson to approve the Final Reading of Recommended policies. Roll call vote was taken with all present voting yea. Motion carried.

There was a brief discussion regarding the ED program and the second emergency amendment to the Part 1 emergency rules filed by ISBE for the use of isolated time out in limited circumstances.

At 10.02 a.m., Wyatt moved, seconded by Kraemer to go into executive session to discuss the appointment, employment, compensation, discipline, performance, or dismissal of specific employees and collective negotiations. Roll call vote was taken with all present voting yea. Motion carried.

At 10:19 a.m., Kraemer moved, seconded by Johnson to return to regular session. Roll call vote was taken with all present voting yea. Motion carried.
