TENTATIVE MINUTES

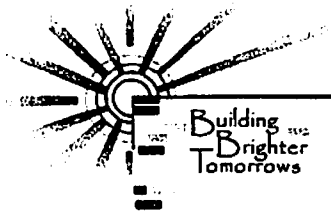
